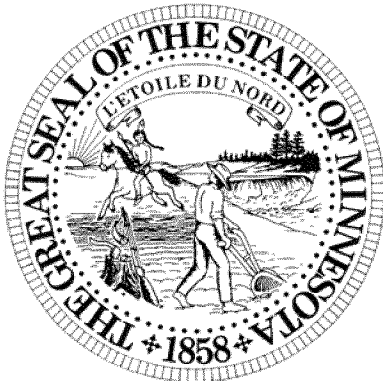


**ARTICLES OF CONVERSION  
OF

(a Minnesota corporation)  
TO

(a Minnesota limited liability company)**

These Articles of Conversion have been duly executed and are being filed by Suburban Manufacturing, Inc. a Minnesota corporation (the "Converting Organization"), pursuant to Section 302A.682 of the Minnesota Business Corporation Act to convert into another organization:

1. The name of the Converting Organization before the filing of these Articles of Conversion is Suburban Manufacturing, Inc., and the name to which the Converting Organization is being converted is Suburban Manufacturing, LLC (the "Converted Organization").
2. The Converted Organization will be a Minnesota limited liability company.
3. The conversion shall be effective at 12:00 AM on June 20, 2023.
4. The Plan of Conversion is attached hereto as Exhibit A, and has been approved by the Converting Organization in accordance with Chapter 302A of the Minnesota Statutes.
5. The conversion was approved as required by Chapter 322C of the Minnesota Statutes, the governing statutes of the Converted Organization.
6. Attached hereto as Exhibit B is a true and correct copy of the Articles of Organization of the Converted Organization.

## PLAN OF CONVERSION SUBURBAN MANUFACTURING, INC.

The undersigned, on behalf of Suburban Manufacturing, Inc., a Minnesota corporation, for the purpose of converting Suburban Manufacturing, Inc. from a domestic Minnesota corporation to a domestic Minnesota limited liability company, and pursuant to Chapter 322C of the Minnesota Statutes (the "MLLCA") and Chapter 302A of the Minnesota Statutes hereby states as follows:

- 1) The name of the converting organization is Suburban Manufacturing, Inc., a Minnesota corporation (the "Converting Organization").
- 2) The name of the converted organization will be Suburban Manufacturing, LLC (the "Converted Organization").
- 3) The Converted Organization will be a limited liability company formed under the laws of the State of Minnesota.
- 4) The Converting Organization is continuing its existence in the form of a limited liability company as the Converted Organization.
- 5) The effective date of the conversion contemplated hereby shall be June 20, 2023 (the "Effective Date").
- 6) On the Effective Date, one hundred percent (100%) of the issued outstanding shareholder interests (the "Old Interests") of the Converting Organization shall be exchanged for one hundred percent (100%) of the membership interests (the "New Interests") in the Converted Organization.
- 7) The Converted Organization shall be managed by its sole member. As of the Effective Date, the sole member of the Converted Organization shall adopt resolutions electing officers of the Converted Organization, approving the operating agreement, and addressing such other matters necessary in connection with organizational issues for the Converted Organization.
- 8) As of the Effective Date, the sole shareholder of the Converting Organization shall be considered the sole member of the Converted Organization.
- 9) On the Effective Date, the shareholder agreement and bylaws and any amendments thereto, of the Converting Organization shall be deemed terminated.
- 10) In accordance with Section 322C.1010 of the MLLCA, the Converted Organization shall for all purposes continue to be the same organization as the Converting Organization and shall be considered to have been organized on the date that the Converting Organization was originally organized; provided, however, that the Converted Organization shall be a Minnesota limited liability company as of the Effective Date. Upon the Effective Date:

- a) all property owned by the Converting Organization remains vested in the Converted Organization (as a Minnesota limited liability company) rather than in its prior organizational form (as a Minnesota corporation);
  - b) all debts, obligations, or other liabilities of the Converting Organization continue as debts, obligations, or other liabilities of the Converted Organization;
  - c) an action or proceeding pending by or against the Converting Organization may be continued as if the conversion had not occurred; and
  - d) all of the rights, privileges, immunities, powers, and purposes of the Converting Organization remain vested in the Converted Organization.
- 11) There are no terms and conditions of the proposed conversion other than the terms and conditions contained in this Plan of Conversion.
- 12) A copy of the proposed Articles of Organization of the Converted Organization is attached hereto as Schedule A, and such Articles of Organization shall be the Articles of Organization of the Converted Organization on the Effective Date.
- 13) Upon the effectiveness of the conversion, the authority of the Converting Organization's registered agent to accept service on its behalf is revoked. At such time, the Minnesota Secretary of State is irrevocably appointed as the agent for service of process on the Converted Organization in any proceeding to enforce an obligation of the Converting Organization arising prior to the Effective Date or the rights of dissenting members of the Converting Organization. The Minnesota Secretary of State shall mail any such process to the Converted Organization at 10531 Dalton Ave NE Monticello, MN 55362. The Converted Organization shall notify the Minnesota Secretary of State of any changes to its mailing address. The Converted Organization shall promptly pay to the dissenting shareholders of the Converting Organization the amount, if any, to which the dissenting shareholders are entitled under the Minnesota corporate Act.


