PATENT SECURITY AGREEMENT

This PATENT SECURITY AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Patent Security Agreement”) dated as of August 15, 2024, is made by the Persons listed on the signature pages hereof (collectively, the “Grantors”) in favor of each of Natura &Co Holding S.A., Natura &Co Luxembourg Holdings S.À R.L., Natura Cosméticos S.A. and Natura &Co UK Holdings Limited (each, a “Secured Party” and together, the “Secured Parties”).

Reference is made to the Superpriority Senior Secured Debtor-in-Possession Credit and Guaranty Agreement, dated as of August 12, 2024 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “DIP Credit Agreement”), among Avon Products, Inc., as lead borrower (the “Parent Grantor”), the Co-Borrowers (as defined therein) from time to time party thereto, the guarantors from time to time party thereto and Natura &Co Holding S.À R.L., Natura &Co Luxembourg Holdings S.À R.L., Natura Cosméticos S.A. and Natura &Co UK Holdings Limited, as lenders (the “Lenders”).

Whereas, in order to provide security for the Secured Obligations under the DIP Credit Agreement for the benefit of the Lenders each Grantor has executed and delivered that certain Security Agreement dated as of August 12, 2024, made by the Parent Grantor and the other Grantors to the Secured Parties (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”).

Whereas, under the terms of the Security Agreement, the Grantors have granted to the Secured Parties, a security interest in, among other property, certain Intellectual Property of the Grantors, and have agreed as a condition thereof to execute this Patent Security Agreement for recording with the United States Patent and Trademark Office and other governmental authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:

SECTION 1. Terms. Terms defined in the DIP Credit Agreement and Security Agreement and not otherwise defined herein are used herein as defined in the DIP Credit Agreement and Security Agreement.

SECTION 2. Grant of Security. Each Grantor hereby grants to the Secured Parties, and their successors and assigns, a continuing security interest in all of such Grantor’s right, title and interest in, to and under the Patents owned by such Grantor, including the Patents set forth on Schedule A attached hereto (the “Patent Collateral”).

SECTION 3. Security for Obligations. The grant of a security interest in the Patent Collateral by each Grantor under this Patent Security Agreement is made to secure the payment or performance, as the case may be, in full of the Secured Obligations.

SECTION 4. Recordation. Each Grantor authorizes and requests that the Commissioner for Patents and any other applicable government officer record this Patent Security Agreement.

SECTION 5. Execution in Counterparts. This Patent Security Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 6. Security Agreement. This Patent Security Agreement has been entered into in conjunction with the provisions of the Security Agreement. Each Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Secured Parties with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.






