- (b) all causes of action (whether currently pending, filed, or otherwise) and other enforcement of rights under, or on account of, any of the Patents and/or any item in category (a) including, without limitation, all causes of action and other enforcement rights for (i) damages, (ii) injunctive relief, and (iii) other remedies of any kind for past, current and future infringement.

Assignor agrees to complete all acts and execute all documents, and to ensure that its officers, employees and agents complete all acts and execute all documents, necessary to secure Assignor's or its designee's ownership of Patent Rights.

If any term or provision of this Assignment of Patent Rights shall to any extent be invalid or unenforceable, the remaining terms shall not be affected thereby and each term and provision of the assignment shall be valid and enforced to the fullest extent permitted by law.


