**RELEASE OF CONFIRMATORY GRANT OF SECURITY
INTEREST IN PATENTS**

THIS RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN PATENTS, dated as of August 23, 2024, (this “Release”) is made by **JPMORGAN CHASE BANK, N.A.** (“Grantee”) for itself and as Administrative Agent for the Secured Parties under the Confirmatory Grant of Security Interest in Patents (as amended, supplemented or modified and in effect from time to time, the “Patent Security Agreement”), between **ICONEX LLC**, a Delaware limited liability company (the “Company”), **MAX INTERNATIONAL CONVERTERS INC.**, a Delaware corporation (“MAX International Converters”), **MAXSTICK PRODUCTS LTD.**, a Delaware corporation (“MAXStick Products”, and collectively with the Company and MAX International Converters, the “Grantors”, and each, “Grantor”) and the Grantee. Capitalized terms used but not defined herein have the meanings provided in the Patent Security Agreement.

WHEREAS, pursuant to the Patent Security Agreement which was recorded at the United States Patent and Trademark Office on June 30, 2023 at Reel 064179 Frame 0848, the Grantors granted to the Grantee a continuing security interest in all of Grantors’ right, title and interest in Patents, including those set forth on the attached Exhibit A.

WHEREAS, Grantors have requested and the Grantee has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Patent Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Grantee does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Patent Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Grantee in the Released Collateral, and (d) reassigns, grants and conveys to Grantors any and all right, title and interest each has in the Released Collateral.
