## Patent Assignment Agreement

This Patent Assignment Agreement ("**Patent Assignment**"), effective as of January 1, 2024, is made by Otsuka America, Inc., a Delaware corporation, located at One Embarcadero Center, Suite 2020, San Francisco, California 94111 ("**Assigning Party**" or "**Assignor**"), in favor of Otsuka Precision Health, Inc., a Delaware corporation, located at 508 Carnegie Center, Princeton, New Jersey 08540 ("**Assuming Party**" or "**Assignee**"), the acquirer of certain rights, obligations, and assets of Assignor pursuant to the Assignment and Assumption Agreement between Assignee and Assignor dated as of January 1, 2024 (the "**Assignment and Assumption Agreement**").

WHEREAS, under the terms of the Assignment and Assumption Agreement, Assignor has conveyed, transferred, and assigned all of its rights and delegated all of its obligations under certain contracts to Assignee, and, to the extent not already done so by the Assignment and Assumption Agreement, desires to convey, transfer, and assign to Assignee, among other assets, certain intellectual property of Assignor, and agrees to execute and deliver this Patent Assignment, for recording with the United States Patent and Trademark Office and corresponding entities or agencies in any applicable jurisdictions;

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has conveyed, transferred, and assigned and/or does hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor's right, title, and interest in and to the following (the "**Assigned Patents**"):

(a) the patents and patent applications set forth on Schedule 1 hereto and any and all inventions described therein and to any and all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations, renewals, Letters Patent and certificates of the United States, foreign countries, and all regions worldwide which may be obtained therefor (the "**Inventions**");

(b) all the rights, privileges, and benefits therein, and all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world, including any and all rights, privileges, and benefits under the Paris Convention for the Protection of Industrial Property, including the right to claim priority based on said Inventions, and under any and all Letters Patent or patents which may be granted therefor, and all right, title, and interest in and to every patent application filed or to be filed on or in relation wholly or partly to said Inventions in any country or patent organization, including continuations, divisions, renewals, revivals, and any substitute applications of said patent application(s), and all the rights, privileges, and benefits therein, including the right to claim priority based on said Inventions, and all right, title, and interest in and to any and all patents which may issue thereon, and any reissues, reexaminations, pipelines, extensions, supplementary protection certificates, and governmental exclusivity rights extending therefrom;

(c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Assignor hereby authorizes the Commissioner for Patents in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Patent Assignment upon request by Assignee.

(a) Following the date hereof, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Assigned Patents to Assignee, or any assignee or successor thereto.

(b) Assignor hereby covenants and agrees to and with the Assignee, its successors, legal representatives, and assigns that the Assignor will, whenever counsel of the Assignee, or the counsel of its successors, legal representatives, and assigns, shall advise that any proceeding in connection with said Inventions, said application(s), said patent(s), any application claiming priority to said application(s), any reissue or extension of said patent(s), and any United States or foreign Letters Patent or Patents for said Inventions or said application(s), including interference and derivation proceedings, and any post-grant proceedings (e.g., opposition proceedings, post-grant reviews, *Inter partes* reviews, supplemental examinations, etc.), is lawful and desirable, sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of Letters Patent or Patents for said Invention, without charge to the Assignee, its successors, legal representatives, and assigns, but at the cost and expense of the Assignee, its successors, legal representatives, and assigns

3. Terms of the Assignment and Assumption Agreement. The parties hereto acknowledge and agree that this Patent Assignment is entered into pursuant to the Assignment and Assumption Agreement, to which reference is made for a further statement of the rights and obligations of Assignor and Assignee with respect to the Assigned Patents. The representations, warranties, covenants, agreements, and indemnities contained in the Assignment and Assumption Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Assignment and Assumption Agreement and the terms hereof, the terms of the Assignment and Assumption Agreement shall govern.

4. Counterparts. This Patent Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Patent Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Patent Assignment.



5. Successors and Assigns. This Patent Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.


