**TERMINATION AND RELEASE OF
PATENTS**

THIS TERMINATION AND RELEASE OF PATENTS ("Release") is made as of October 1, 2024, by WhiteHorse Capital Management, LLC, in its capacity as Administrative Agent ("Agent"), in favor of Industrial Specialty Services USA LLC, a Delaware limited liability company (the "Grantor").

WHEREAS, the Grantor entered into a certain Security and Pledge Agreement with Agent, dated December 31, 2021 (the "Security Agreement"), notice of which was recorded with the United States Patent and Trademark Office on January 3, 2022, at reel/frame 058528/0674. Capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

WHEREAS, Grantor granted to Agent, under the terms of the Security Agreement, certain security interests in favor of Agent, in and to all of their rights, titles and interests in and to the Patents, which include without limitation the patents and corresponding registrations and applications listed in Schedule 1 together with the goodwill of the business symbolized thereby (the "Patent Collateral").

WHEREAS, Agent has agreed to terminate and release all of its security interests and liens in all such Patent Collateral as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby fully releases, terminates and discharges all of its security interests and liens in the Patent Collateral, which include the patents, registrations and applications listed on the schedules attached hereto and made a part hereof, and assigns, transfers and conveys to Grantor any and all right, title, and interest in and to such Patent Collateral, including the security interests and hereby terminates the Security Agreement.

If and to the extent the Agent has acquired any right, title or interest in, to or under any of the Patent Collateral, without any representation, recourse or undertaking by the Agent, it hereby irrevocably reassigns and retransfers all such right, title and interest to the Grantor.

Agent authorizes Grantor, or Grantor's authorized representatives, to record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency.

Agent agrees to execute and deliver to the Grantor, at the Grantor's expense, all other instruments and other documents as may be reasonably necessary or proper to release the security interest in the Patent Collateral which had been granted under the Security Agreement.

This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York without regard to conflict of laws principles thereto.
