SUPPLEMENTAL INTELLECTUAL PROPERTY ASSIGNMENT

THIS SUPPLEMENTAL INTELLECTUAL PROPERTY ASSIGNMENT (“**Assignment**”) is made and effective this 24th day of July, 2024, by and between 17 Thrasio Seventeen, Inc., a Delaware corporation (“**Seller**”) and **CKnapp Sales, Inc.**, an Illinois corporation (“**Buyer**”).

WHEREAS, Seller owns the Trademarks and Patents set forth on Exhibit A attached hereto (the “**IP Registrations**”);

WHEREAS, in connection with that Asset Purchase Agreement, by and between Seller and Buyer, of even date herewith (the “**Purchase Agreement**”), Buyer has acquired all the intellectual property of Seller including the IP Registrations (collectively, the “**Seller IP**”); and

WHEREAS, Seller and Buyer entered into a prior Intellectual Property Assignment and wish to supplement that assignment with this Agreement;

NOW, THEREFORE, in consideration of the mutual covenants contained herein and in the Purchase Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Seller hereby irrevocably sells, assigns, transfers and conveys to Buyer, its successors and assigns, free and clear of all liens, licenses, restrictions and other encumbrances, the entire right, title and interest in and to the IP Registrations and any applications or IP Registrations related to any of the foregoing IP Registrations, together with the goodwill of the business in which the IP Registrations are used and for which it is registered, all rights of priority, and the right to claim and retain any past, present or future damages for infringement.
2. Seller hereby agrees to execute all papers and to perform such other proper acts and to provide such information and documents and all such other assistance as Buyer may reasonably deem necessary to evidence and secure for Buyer the rights, including rights in the Seller IP, herein assigned, including recordation of this Assignment.
3. This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware without regard to conflict of law principles.
4. This Assignment may be signed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
