The foregoing assignment shall also include assignment of all rights to assert, to sue for, and to recover all damages and other remedies for, any and all infringement of the Patent Property that occurred prior to the date of this Patent Assignment.

AND for the same consideration, Assignor hereby warrants, covenants, and agrees to and with said Assignee, its successors, legal representatives and assigns, that, at the time of execution and delivery of these presents, said Assignor is the sole lawful owner of the entire right, title and interest in and to the above-referenced Patent Property and to the inventions disclosed in the Patent Property, and that the same is unencumbered and that said Assignor has good and full right and lawful authority to sell and convey the same in the manner herein set forth.

AND for the same consideration, Assignor agrees to execute or procure any further necessary assurance of title to said Patent Property; and at any time, upon the request of said Assignee, will execute and deliver any and all papers that may be necessary or desirable to perfect the title to the Patent Property and rights assigned herein in Assignee, its successors, assigns or other legal representatives.
