NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby assigns to ASSIGNEE, its successors and assigns, ASSIGNOR's entire right, title and interest in and to the Patent Rights;

All of the same to be held and enjoyed by ASSIGNEE, for its own use and benefit and for the use and benefit of its successors, assigns and other legal representatives to the full extent of the terms for which the Patent Rights are granted, and for the Patent Rights which may be granted in respect of any Patent Applications, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR had this ASSIGNMENT OF PATENT RIGHTS not been made.

ASSIGNOR covenants that ASSIGNOR has full right to convey the entire right, title and interest herein assigned, and that ASSIGNOR has not executed and will not execute any agreement in conflict herewith.


ASSIGNOR authorizes and requests the Commissioner of Patents & Trademarks to record ASSIGNEE as the assignee and owner of the Patent Rights in the U.S. Patent & Trademark Office, and to issue any and all Patents to ASSIGNEE.

ASSIGNOR agrees to perform all affirmative acts which may be necessary to obtain a grant of any valid United States patent or patent in any foreign country to the ASSIGNEE. ASSIGNOR agrees to execute all papers necessary in connection with any interference, derivative proceeding, reexamination, opposition, post grant proceeding, *inter partes* review, and any other legal proceeding or cause of action which may be declared concerning the Patent Rights, and to cooperate with ASSIGNEE in every way possible in obtaining evidence, including evidence of conception, reduction to practice and/or inventorship as needed. ASSIGNOR agrees to execute any other documents necessary to effect and record this ASSIGNMENT OF PATENT RIGHTS.

The undersigned hereby grant(s) all attorneys and agents associated with Customer No. 69849 the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
