REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is executed as of September 4, 2024, by **SILICON VALLEY BANK, a division of FIRST-CITIZENS BANK & TRUST COMPANY** (the "Assignor") to and for the benefit of **BLUE WHITE ROBOTICS LTD.**, a company organized under the laws of the State of Israel, with its principal place of business at 12 Kaplan Street, Tel Aviv, Israel (the "Assignee").

A. WHEREAS, Assignor wishes to release in full its security interest in the Intellectual Property Collateral (as defined in the Security Agreement), and to reassign, without warranty or recourse, all right, title and interest that Assignor may have in the Intellectual Property Collateral (as defined in the Security Agreement).

AGREEMENT

Now, therefore, Assignor agrees that it hereby terminates and releases in full its security interest in the Intellectual Property Collateral (as defined in the Security Agreement) granted pursuant to the Security Agreement or otherwise, and reassigns to Assignee, without warranty or recourse, all right, title and interest of Assignor in, to and under the Intellectual Property Collateral (as defined in the Security Agreement).
