PATENT ASSIGNMENT CONTRACT

BETWEEN:

The company **IDEMIA FRANCE**, formerly OBERTHUR TECHNOLOGIES, a simplified joint-stock company, registered in the Register of Companies of Nanterre under number 340 709 534, having its registered office at 2, Place Samuel de Champlain - 92 400 Courbevoie, hereinafter referred to as '**IDEMIA FRANCE**'; and

The company **IDEMIA IDENTITY & SECURITY FRANCE**, a simplified joint stock company, registered in the Register of Companies of Nanterre under number 440 305 282, having its registered office at 2, Place Samuel de Champlain - 92400 Courbevoie, France, hereinafter referred to as '**IDEMIA I&S**';

On the one hand,

AND:

Mr Jean-Pierre LAZZARI [REDACTED]

[REDACTED] and

Mr Jean-Marc LAZZARI, [REDACTED]

Acting jointly and severally, hereinafter referred to together as '**Messrs LAZZARI**' or the '**Assignors**';

On the other hand,

hereinafter individually referred to as a 'Party' and collectively as the 'Parties'.

It is understood that IDEMIA I&S will freely decide this policy of modification, extension and maintenance in accordance with its own strategy, as owner of the PATENTS. The Assignors may not object in any way, even if these acts result in a limitation or modification of the scope of the PATENTS, or more generally, a loss of rights.

The Assignors undertake to provide, upon the simple request of IDEMIA I&S, any documents and signatures that may be necessary, including the signature, recognition and registration of specific transfers, certificates, declarations and other documents so that IDEMIA I&S can fully enjoy all the rights associated with the assignment, country by country.

ARTICLE 2 – FINANCIAL TERMS

In return for the assignment of the PATENTS, IDEMIA I&S agrees to pay a price, the amount and payment terms of which are explained in detail in **Appendix 2**.

ARTICLE 3 - INFRINGEMENT

IDEMIA I&S, as the sole owner of the PATENTS, shall decide at its discretion and at its sole risk and benefit, to claim and receive all damages and/or royalties owed by any third-party infringers of the PATENTS for infringement or usurpation actions prior and/or subsequent to the Effective Date.

If infringement proceedings (or more broadly, any claim based on an infringement of an intellectual property right) are initiated against IDEMIA I&S or its licensees in connection with the PATENTS, the Assignors shall provide, at their own expense, to IDEMIA I&S and/or its licensees with their technical assistance for their defence. In this respect, the Assignors undertake to provide IDEMIA I&S with all documents, powers and signatures that IDEMIA I&S may require in connection with the aforementioned proceedings.

ARTICLE 4 –TRANSFER OF OWNERSHIP

The transfer of ownership of the PATENTS will take place on 1st January 2024 (the '**Effective date**').

The Licence, concluded between Messrs LAZZARI and IDEMIA FRANCE, will be terminated automatically at midnight on 31 December 2023.

On the Effective Date, Messrs LAZZARI's ownership of the PATENTS will be transferred automatically to IDEMIA I&S.

ARTICLE 5 – ENTRY INTO FORCE - TERM

The Assignment Contract shall come into force on the date of its signature. It expires on 31 Decem [REDACTED]

ARTICLE 6 – FEES AND REGISTRATIONS

All costs, duties, taxes and fees due for all formalities relating to the assignment of the PATENTS shall be borne by IDEMIA I&S.

This Assignment Contract shall be registered at the request and expense of IDEMIA I&S with the industrial property offices of the countries in which the PATENTS are registered.

In order to register the Assignment Contract with the said offices and to have it mentioned wherever necessary, full powers are given to the bearer of a copy of this document.

ARTICLE 7 – CONFIDENTIALITY

The technical information provided for in Article 3 of the Assignment Contract, as well as Appendix 2 and the related financial information, is considered to be confidential information. Consequently, it may not be communicated to third-parties (other than IDEMIA I&S's parent companies, subsidiaries and sister companies and its statutory auditors) without the prior and written consent of the other Party, with the exception of communications to their intellectual property advisors and tax authorities.

This undertaking will remain in force for a period of ten (10) years after the expiry date of the Assignment Contract stipulated in Appendix 2.

ARTICLE 8 – APPLICABLE LAW AND SETTLEMENT OF DISPUTES

The Assignment Contract is governed by French law.

The Parties shall endeavour to resolve any dispute, relating to the Assignment Contract, in an amicable manner. In the absence of an amicable agreement, the Paris Court of Justice shall have jurisdiction.
