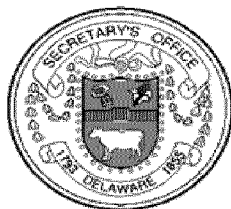

**CERTIFICATE OF AMENDMENT TO THE
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF
VECTRA NETWORKS, INC.**

Vectra Networks, Inc. (the “*Corporation*”), a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the “*DGCL*”), does hereby certify:

FIRST: That the Corporation was originally incorporated pursuant to the DGCL on December 14, 2011, under the name TraceVector, Inc.

SECOND: Pursuant to Section 242 of the DGCL, this Certificate of Amendment to the Amended and Restated Certificate of Incorporation amends certain provisions of the Corporation’s Amended and Restated Certificate of Incorporation.

THIRD: The terms and provisions of this Certificate of Amendment to the Amended and Restated Certificate of Incorporation have been duly approved by written consent of the required number of shares of outstanding stock of the Corporation pursuant to Subsection 228(a) of the DGCL.

FOURTH: Article I of the Corporation’s Amended and Restated Certificate of Incorporation is hereby amended to read in its entirety as follows:

“The name of this Corporation is Vectra AI, Inc. (the “*Corporation*”).”

IN WITNESS WHEREOF, this Certificate of Amendment of the Amended and Restated Certificate of Incorporation, which amends certain provisions of the Amended and Restated Certificate of Incorporation of the Corporation, having been duly adopted in accordance with Section 242 of the DGCL, has been duly executed by its President and Chief Executive Officer on November 6, 2018.
