**RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL** (this “**Release**”) is made as of September 13, 2024 by ANKURA TRUST COMPANY, LLC, as the Collateral Agent (in such capacity, the “**Collateral Agent**”), in favor of RODAN & FIELDS, LLC (a “**Grantor**”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Patent Security Agreement (defined below), or if not defined therein, in the Security Agreement (defined below).

**WHEREAS**, the Grantor is a party to that certain (i) Extended Term Loan Pledge and Security Agreement, dated as of April 27, 2023 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) by and among the Grantor, the other grantors party thereto and the Collateral Agent and (ii) Patent Security Agreement, dated as of April 27, 2023, by the Grantor in favor of the Collateral Agent (the “**Patent Security Agreement**”), which was recorded with the United States Patent and Trademark Office at Reel 063480, Frame 0786 on April 28, 2023;

**WHEREAS**, pursuant to the Security Agreement and the Patent Security Agreement, the Grantor granted to the Collateral Agent a security interest in all of such Grantor’s right, title and interest in and to the Patent Collateral, including the Patents set forth on Schedule A hereto;

**WHEREAS**, the Grantor has requested that the Collateral Agent terminate, release and discharge fully its lien on and security interest in all right, title and interest of the Grantor in and to the Patent Collateral, including each patent and patent application listed on the attached Schedule A hereto, and execute a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its lien on and security interests in the Collateral as herein provided.

**NOW THEREFORE**, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without representation or warranty of any kind, hereby releases, relinquishes and discharges, the security interest in and to all of each Grantor’s right, title, and interest in and to the Patent Collateral, and re-assigns to each Grantor any and all right, title or interest it may have in such Patent Collateral.

The Collateral Agent hereby authorizes the Grantor, or the Grantor’s authorized representatives, to record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency. The Collateral Agent agrees to execute and deliver to the Grantor other instruments and other documents, and do all further acts which the Grantor (or its agents or designees) reasonably request, at the Grantor’s sole cost and expense, as may be necessary to release the lien on and security interest in the Patent Collateral which had been granted under the Patent Security Agreement.

**THIS RELEASE AND ANY CLAIMS, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THEREOF THAT WOULD RESULT IN THE APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK (OTHER THAN ANY MANDATORY PROVISIONS OF LAW RELATING TO THE LAW GOVERNING PERFECTION AND THE EFFECT OF PERFECTION OF THE SECURITY INTEREST).**


