**ASSIGNMENT** (*this “Assignment”*)

WHEREAS, the ASSIGNOR is the Personal Representative acting on behalf of the estate of the late Tylor Christian Ross, previously residing at 68613 Oak Spring Road, Edwardsburg, Michigan 49112, who died on September 12, 2023 and is joint owner of 50% undivided interest in all right, title, and interest of various patents (“Inventions”) as fully set forth and described as covered by the patent rights listed in the attached *Appendix A* (herein the “Patent Rights”); and

Assignor further assigns, sells, transfers, and convey to Assignee, its successors and assigns all claims for damages and all remedies arising out of any violation of the rights assigned hereby that may have accrued prior to the date of this Assignment or may accrue hereafter, including, but not limited to, the right to sue for, collect, and retain damages for any infringement of the Patent Rights.

Further Assistance. Assignor hereby promises and agrees, upon Assignee’s request, to execute such additional papers and instruments necessary, expedient, and permissible to procure and to convey to the Assignee the entire right, title, and interest in and to the Patent Rights


Successors in Interest. This Assignment shall be binding upon and inure to the benefit of the respective heirs, successors, legal representatives, and assigns of Assignor and Assignee.

Power to Insert. The undersigned hereby grant(s) the firm of Botkin & Hall, LLP the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
