**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Termination and Release of Security Interest in Intellectual Property (“Release”) is made as of November 1, 2024, by **MACQUARIE CAPITAL FUNDING LLC**, a Delaware limited liability company (in such capacity, together with its successors and assigns, “Collateral Agent”) in favor of **BRAHMA GROUP, INC.**, a Nevada corporation with an address at 1132 South 500 West, Salt Lake City, Utah 84101, **TERRA MILLENNIUM CORPORATION**, a Delaware corporation with an address at 1132 South 500 West, Salt Lake City, Utah 84101, and **J.T. THORPE INTERNATIONAL, INC.**, a Nevada corporation with an address at 1060 Hensley St., Richmond, California 94801 (each, a “Grantor” and collectively, the “Grantors”).

**W I T N E S S E T H:**

WHEREAS, the Grantors entered into a certain Intellectual Property Security Agreement dated June 30, 2022 (the “IP Security Agreement”) with Collateral Agent, notice of which was recorded on July 5, 2022 at the United States Patent and Trademark Office at Reel 060573, Frame 0383 with respect to the Patents, and at Reel 7770, Frame 0250 with respect to the Trademarks.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, each Grantor granted the Collateral Agent, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in all of each such Grantor’s right, title and interest in and to the Collateral, including without limitation the Patents and Trademarks listed in **Schedule A** (collectively, the “IP Collateral”).


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such IP Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) any and all of its interest in the IP Collateral of the Grantors, and assigns, transfers and conveys to each Grantor (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) any interest in such IP Collateral, including the Security Interest.
