TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination"), is dated as of November 21, 2024, and made by **THE HUNTINGTON NATIONAL BANK**, a national banking association ("Lender"), in favor of **STANSPORT, LLC**, a Nevada limited liability company, and **STANDARD SALES, LLC**, a California limited liability company (collectively, "Borrowers"), with reference to the following facts:

RECITALS

A. Pursuant to that certain Intellectual Property Security Agreement dated as of March 31, 2022, made by Borrowers in favor of Lender (the "IP Security Agreement"), Borrowers granted Lender a security interest in the intellectual property of Borrowers, including the IP Collateral (as hereinafter defined).

B. The IP Security Agreement was recorded with the patent division of the United States Patent and Trademark Office on April 19, 2022, at Reel/Frame 059638/0368 and with the trademark division of the United States Patent and Trademark Office on April 4, 2022, at Reel/Frame 7680/0343.

C. Lender now desires to terminate the IP Security Agreement and to terminate, release and discharge its security interest in the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Lender hereby agrees and states as follows:

1. Definitions. The term "IP Collateral," as used herein, shall mean all of Borrowers' right, title and interest of every kind and nature as of the date hereof in the copyrights, patents, trademarks, domain names and other intellectual property of the Borrowers, including, without limitation:

- (a) the copyrights described on Exhibit A hereto;
- (b) the patents described on Exhibit B hereto;
- (c) the trademarks described on Exhibit C hereto; and
- (d) the domain names described on Exhibit D hereto.

2. Release of Security Interest. Grantee hereby terminates the IP Security Agreement and terminates, releases and discharges (without any recourse, representation or warranty) its security interest in the IP Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Lender in the IP Collateral.

IN WITNESS WHEREOF, Lender has caused this Termination to be executed by its duly authorized officer as of the date first written above.

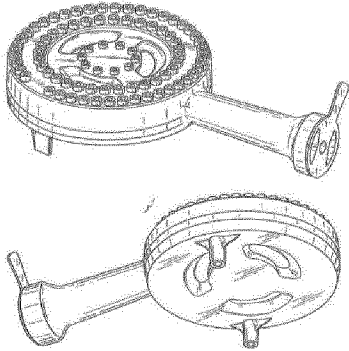
