DECLARATION

I, Christopher A. Baxter, declare and say:

1. A Patent Security Agreement (hereinafter the "Agreement"), between Soliyarn Inc. (hereinafter "Soliyarn") and Reading Cooperative Bank (hereinafter "Reading"), dated April 8, 2024, granted a security interest to Reading in US Patent Nos. 10,832,873; 11,166,344; and 11,825,569 (hereinafter collectively the "US Patents").
2. The Agreement was recorded against the US Patents on April 8, 2024 at Reel 067033, Frame 0667.
3. After the Agreement was recorded, I received notice that Soliyarn did not have any rights in the US Patents and for which a security interest could be granted.
4. It is thus my understanding that the recording of the Agreement against the US Patents was in error.
