## **RELEASE OF SECURITY INTEREST IN PATENTS**

This RELEASE OF SECURITY INTEREST IN PATENTS (this “Release”), dated as of November 25, 2024 (the “Effective Date”), is made by BANK OF AMERICA, N.A., in its capacity as Collateral Agent (the “Agent”), in favor of Jostens, Inc. (the “Grantor”).

WHEREAS, pursuant to that certain First Lien Security Agreement, dated as of December 21, 2018, by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “First Lien Security Agreement”), the Grantor granted to the Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral, including the patents and patent applications set forth on Schedule I attached hereto (the “Patent Collateral”);

WHEREAS, pursuant to the First Lien Security Agreement, the Grantor executed and delivered (i) a First Lien Patent Security Agreement, dated as of December 21, 2018 (the “2018 First Lien Patent Security Agreement”) and (ii) a First Lien Patent Security Agreement, dated as of March 22, 2023 (the “2023 First Lien Patent Security Agreement”) and together with the 2018 First Lien Patent Security Agreement, the “First Lien Patent Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, (i) the 2018 First Lien Patent Security Agreement was recorded with the United States Patent and Trademark Office on December 21, 2018 at Reel/Frame 047975/0229, and (ii) the 2023 First Lien Patent Security Agreement was recorded with the United States Patent and Trademark Office on March 23, 2023 at Reel/Frame 063154/0309;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the First Lien Security Agreement or the First Lien Patent Security Agreements, as applicable.
2. Release. The Agent, for itself and on behalf of the Secured Creditors, without representation or warranty of any kind, hereby irrevocably releases, discharges, terminates and cancels all of its security interest in and to the Patent Collateral, including the patents and patent applications set forth on Schedule I attached hereto, arising under the First Lien Security Agreement and the First Lien Patent Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Patent Collateral under the First Lien Patent Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.
3. Termination. The Agent, for itself and on behalf of the Secured Creditors, without representation or warranty of any kind, hereby irrevocably terminates and cancels the First Lien Patent Security Agreements.
4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Counterparts. This Release may be executed in counterparts and by different parties hereto in different counterparts, each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Release by facsimile or other electronic imaging means (e.g., "pdf" or "tif") shall be effective as delivery of a manually executed counterpart of this Release. The words "execution," "execute," "signed," "signature," and words of like import in or related to any document to be signed in connection with this Release shall be deemed to include electronic signatures, the electronic matching of assignment terms and contract formations on electronic platforms approved by the Agent, or the keeping of records in electronic form, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.

6. Governing Law. This Release shall be governed exclusively under the laws (including the statutes of limitations) of the State of New York, without regard to conflicts of law or choice of law principles.
