- (5) The right to enforce rights to the Acquired Patents as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made; together with all claims of Assignor for damages by reason of past, present, or future infringement or for provisional rights and including the right to sue for, and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns, and designees.

Assignor further agrees for itself and for its successors and assigns to execute and deliver without further consideration any further instruments, applications, assignments, or other documents as may be requested by Assignee or its legal representatives or designees, and to perform such other lawful acts as Assignee, its successors, and assigns may deem necessary or convenient to fully secure, maintain, perfect, and enforce its

rights, title, or interest in the Acquired Patents or any of the associated rights described in this Agreement.
