RELEASE OF SECURITY INTEREST IN PATENTS

This **RELEASE OF SECURITY INTEREST IN PATENTS**, dated as of December 12, 2024 (the “**Release**”), is made by CERBERUS BUSINESS FINANCE AGENCY, LLC, a Delaware limited liability company, as the Collateral Agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, the “**Releasor**”) in favor of Safe Rack LLC, a South Carolina limited liability company (the “**Releasee**”).

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated as of November 14, 2022 (the “**Security Agreement**”) and that certain Assignment of Security Interest – Trademarks, dated as of November 14, 2022 (the “**Patent Security Agreement**”), recorded with the United States Patent and Trademark Office (the “**USPTO**”) on November 14, 2022 at Reel 061933, Frame 0415, the Releasee granted to the Releasor as agent for itself and certain lenders, a continuing security interest in all right, title and interest of the Releasee in, to and under the patents and patent applications listed on Schedule A attached hereto (the “**Patents**”) and any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the “**Collateral**”); and

WHEREAS, the Releasee has requested, and the Releasor wishes to provide this Release as a document suitable for recording in the USPTO for purposes of recording the release, relinquishment, termination, cancellation and discharge of its continuing security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or the Patent Security Agreement, as applicable.
2. Release of Security Interest. The Releasor, without representation, warranty or recourse, hereby (a) irrevocably releases, relinquishes, terminates, cancels and discharges the Patent Security Agreement and (b) assigns and transfers to Releasee all of Releasor’s right, title and interest in and to the Collateral, including the Patents listed on Schedule A hereto.
3. Recordation. Releasor hereby authorizes and requests that the Commissioner for Patents of the USPTO record and register this Release.
4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
