**PARTIAL TERMINATION AND RELEASE OF
SECURITY INTEREST IN PATENTS**

This Partial Termination and Release of Security Interest in Patents (“Patent Release”) is made as of December 12, 2024, by **HERCULES CAPITAL, INC.** in its capacity as administrative agent and collateral agent for itself and Lenders (in such capacity, including any successors or assigns, “Agent”) in favor of **PINDROP SECURITY, INC.**, a Delaware corporation (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor has entered into a certain Intellectual Property Security Agreement, dated as of June 26, 2024 (the “IP Security Agreement”), by the Borrower in favor of the Agent for the benefit of the Lenders with Agent, notice of which was recorded on June 26, 2024, at the United States Patent and Trademark Office at Reel 067867, Frame 0860.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, the Grantor granted the Agent, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Agent, in and to all of the Grantor’s right, title and interest in the Patents listed in **Schedule A** (the “Released Collateral”).

WHEREAS, the Agent has agreed to terminate and release its Security Interest in the Released Collateral.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent hereby releases, terminates and discharges the Security Interest in the Released Collateral of the Grantor.
