**ASSIGNMENT**

**THIS AGREEMENT** is made on the date of the last signature below

**BETWEEN**

- (1) **JOHNSON MATTHEY PUBLIC LIMITED COMPANY**, a company incorporated and registered in England with company number 33774, the registered office of which is at 5<sup>th</sup> Floor, 25 Farringdon Street, London EC4A 4AB, England including its subsidiary companies Tracerco Limited and Ilumink Limited (hereinafter together the "Assignor")
- (2) **CAMBRIDGE ENTERPRISE LIMITED**, a company incorporated and registered in England with company number 1069886, the registered office of which is at The Old Schools, Trinity Lane, Cambridge CB2 1TN, England (hereinafter the "Assignee")

(Parties (1) and (2) being referred to in this Agreement together as "the Parties" and each as a "Party").


**WHEREAS**

- (A) The Assignor is the registered owner of US patent number 9,720,173 (the "Patent").
- (B) Based on an agreement dated 12 February 2015 between Tracerco Limited, Ilumink Limited (both subsidiaries of the Assignor Johnson Matthey PLC) and Cambridge Enterprise Limited (the Assignee), it was agreed that if the Assignor should wish to abandon the Patent then the Assignor would offer to assign the Patent back to the Assignee.
- (C) The Parties have agreed that the Assignor will now assign the Patent to the Assignee on the terms and conditions set out below.

**NOW, therefore IT IS AGREED** by and between the Parties hereto as follows:


- (1) In consideration of the sum of £1, receipt of which is hereby acknowledged, the Assignor hereby assigns to the Assignee with full title guarantee its respective rights, title and interest in the Patent.
- (2) The rights assigned under Clause 1 include all rights, powers and benefits arising from and accrued to the Patent.
- (3) The Assignor warrants that is the legal and beneficial owner of the patent and has the right and authority to enter into the assignment.
- (4) The Assignor warrants that it has not granted any licences to the Patent and that it is free from any charges, liens, encumbrances or equities.
- (5) The Assignor shall, at the request of the Assignee, do all such further acts and execute all such documents as may be reasonably necessary or reasonably desirable both to secure the proper vesting in the Assignee of all rights assigned to the Assignee.
- (6) This Agreement shall be governed by the law of England and the parties submit to the non-exclusive jurisdiction of the English courts.
