RELEASE OF PATENT SECURITY AGREEMENT

THIS RELEASE dated as of December 27, 2024 (this “Release”) is made by Twin Brook Capital Partners, LLC, as agent for the Lenders and the L/C Issuers (the “Agent”) under that certain Patent Security Agreement, dated as of June 10, 2019 (the “Patent Security Agreement”) by Rotating Machinery Services, Inc., a Pennsylvania corporation (the “Grantor”), in favor of the Agent.

WHEREAS, pursuant to the Patent Security Agreement, which was recorded in the records of the United States Patent and Patent Office on February 28, 2023 at reel 063013, frame 0088, the Grantor granted to the Agent a continuing security interest in all of the Grantor’s right, title and interest in, to and under its owned or thereafter acquired Patent Collateral (as defined in the Patent Security Agreement), including those registered patents and patent applications set forth on Schedule 1 attached hereto; and

WHEREAS, the Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and reassignment of the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, immediately, unconditionally and irrevocably and without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Patent Security Agreement in the Patent Collateral, (b) release its security interest in the Patent Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Patent Collateral and (d) reassign to the Grantor any and all right, title and interest that it may have in the Patent Collateral owned by the Grantor.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
