- 4. <u>APPROVAL:</u> The Plan of Conversion, pursuant to Chapter 47-1A-952 of the Act, is attached hereto as **Exhibit A**, and was approved by the unanimous consent of the Corporation's shareholders on December 10, 2024.
- 5. <u>ARTICLES OF ORGANIZATION:</u> Filed with these articles are the articles of organization of Senproco, LLC in compliance with the requirements of Chapter 47-1A-953 of the Act.
- 6. MANNER AND BASIS OF CONVERSION OF OWNERSHIP: The shares of common stock of the Corporation shall be converted into membership interests of the Company on a 1:1 basis, and, as a consequence, each of the Corporation shareholder's percentage ownership of membership interest of the Company immediately after the conversion shall be the same of such shareholder's percentage ownership of the Corporation's common stock immediately before the conversion.

PLAN OF CONVERSION

This Plan of Conversion governs the conversion of Senproco, Inc., a South Dakota corporation (the "<u>Converting Corporation</u>"), into a South Dakota limited liability company to be named "Senproco, LLC" and to be formed at the time of the conversion (the "<u>Converted LLC</u>"), and is made pursuant to Chapter 47-1A-952 of the South Dakota Codified Laws.

WHEREAS, the Converting Corporation is a corporation organized and existing under the laws of the State of South Dakota, its Articles of Incorporation having been filed originally in the Office of the Secretary of State of the State of South Dakota on June 16, 1999; and

WHEREAS, the Converting Corporation has deemed it advisable and in the best interests of the Corporation to convert into a limited liability company under the laws of the State of South Dakota (the "Conversion").

NOW THEREFORE, the Conversion shall be carried out pursuant to the following terms and conditions:

- 1. The name of the Converting Corporation is "Senproco, Inc."
- 2. The Conversion shall be effective at 4:00 pm EST on December 10, 2024 (the "<u>Effective Time</u>"), following the filing of the Articles of Conversion, substantially in the form attached hereto as <u>Exhibit A</u>, (the "<u>Articles of Conversion</u>") with the Secretary of State of the State of South Dakota.
- 3. The Converted LLC shall be governed by an Articles of Organization to be filed with the Secretary of State of the State of South Dakota, substantially in the form attached hereto as **Exhibit B** (the "").
- 4. The name of the Converted LLC as set forth in the Articles of Organization shall be "Senproco, LLC".
- 5. The jurisdiction of the Converted LLC as set forth in the Articles of Organization is the State of South Dakota.
- 6. The Operating Agreement of the Converted LLC shall be substantially in the form attached hereto as **Exhibit C** (the "**Operating Agreement**").
- 7. Upon the Effective Time, all outstanding shares of the Converting Corporation shall be converted into outstanding membership interest units of the Converted LLC on a one for one basis and shall be of corresponding classes with corresponding rights.

- 8. Upon the Effective Time, the number of managers of the Converted LLC shall be fixed at one, and the manager shall be Daniel Dressen, and such manager shall serve until such time as a successor has been elected and qualified or until such manager's earlier death, resignation or removal.

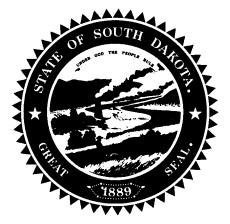
