**RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL** (this “**Release**”) is made as of December 31, 2024 by BANK OF AMERICA, N.A., as the Collateral Agent (in such capacity, the “**Collateral Agent**”), in favor of SINGER SOURCING LIMITED LLC (“**Grantor**”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Patent Security Agreement (defined below), or if not defined therein, in the Security Agreement (defined below).

**WHEREAS**, Grantor is a party to that certain (i) Term Loan Security Agreement, dated as of July 30, 2021 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) by and among Grantor, the other Grantors (as defined therein) and the Collateral Agent and (ii) Amended and Restated Term Loan Patent Security Agreement, dated as of April 4, 2024, by Grantor in favor of the Collateral Agent (the “**Patent Security Agreement**”), which was recorded with the United States Patent and Trademark Office at Reel 067556, Frame 0643 on May 29, 2024;

**WHEREAS**, pursuant to the Security Agreement and the Patent Security Agreement, Grantor pledged and granted to the Collateral Agent a lien on and security interest in all of Grantor’s right, title and interest in, to and under the Patent Collateral, including the Patents set forth on **Schedule A** hereto;

**WHEREAS**, Grantor has requested that the Collateral Agent terminate, release, relinquish and discharge fully its lien on and security interest in all right, title and interest of Grantor in and to the Patent Collateral, and execute a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its lien on and security interests in the Collateral as herein provided.


**NOW THEREFORE**, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without representation or warranty of any kind, and without recourse to it, hereby terminates, releases, relinquishes and discharges fully the lien on and security interest in and to the Patent Collateral granted to it under the Security Agreement and the Patent Security Agreement, and assigns and re-assigns to Grantor any and all right, title or interest it may have under the Security Agreement and the Patent Security Agreement in such Patent Collateral.
