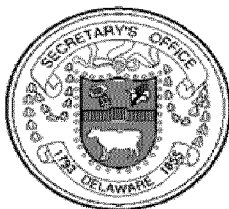

**CERTIFICATE OF AMENDMENT TO  
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION  
OF EAZE SOLUTIONS, INC.**

Eaze Solutions, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the “**DGCL**”), does hereby certify as follows:

**FIRST:** The name of this corporation is Eaze Solutions, Inc. (hereinafter referred to as the “**Corporation**”).

**SECOND:** The Corporation’s original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on September 8, 2014 under the name Eaze Solutions, Inc.

**THIRD:** Pursuant to Section 242 of the DGCL, this Certificate of Amendment to Amended and Restated Certificate of Incorporation of the Corporation (this “**Certificate of Amendment**”) hereby amends the Amended and Restated Certificate of Incorporation of the Corporation, as set forth below:

**1.** Article I of the Amended and Restated Certificate of Incorporation of the Corporation is hereby amended and restated to read in its entirety as follows:

“The name of the Corporation is Eaze Technologies, Inc.”

**2.** Article IV.A of the Amended and Restated Certificate of Incorporation of the Corporation is hereby amended and restated to read in its entirety as follows:

“A. Authorization of Stock. This corporation is authorized to issue two classes of stock to be designated, respectively, common stock, and preferred stock. The total number of shares that this corporation is authorized to issue is **79,699,617**. The total number of shares of common stock authorized to be issued is **49,000,000**, par value \$0.0001 per share (the “**Common Stock**”). The total number of shares of preferred stock authorized to be issued is **30,699,617**, par value \$0.0001 per share (the “**Preferred Stock**”), **4,510,638** of which are designated as “**Series A Preferred Stock**,” **15,823,599** of which are designated as “**Series B Preferred Stock**”, and **10,365,380** of which are designated as “**Series C Preferred Stock**”.

**FOURTH:** This Certificate of Amendment has been duly approved and adopted by the Board of Directors and stockholders of the Corporation in accordance with Sections 141, 228 and 242 of the DGCL.
