Assignor hereby authorizes and requests the United States Patent and Trademark Office, or with respect to any foreign applications or registrations for patents, the foreign equivalent as the case may be, to record Assignee as owner of the Patents and to issue any and all registrations, including renewals thereof, to Assignee, its successors, assigns, nominees or other legal representatives. 
