RELEASE OF SECURITY INTERESTS

THIS RELEASE OF SECURITY INTERESTS (“**Release**”) is made as of this 30th day of December, 2024, by Cedar’s Capital, LLC, a Delaware limited liability company (“**Secured Party**”), which is acting as an agent for the accounts and benefit of Cedar’s Capital, LLC and Dr. Kevin Foley.

WHEREAS, Neurogami Medical, Inc., a California corporation (the “**Granting Party**”) granted a lien, security interest and pledge (“**Security Interest**”) to the Secured Party (as well as to other parties), in a certain “Security Agreement” (the “**Agreement**”) executed between the Granting party and the Secured Party on July 28, 2023, in and to certain property described as “Collateral” in Exhibit A to the Agreement (the “**Collateral**”) which Agreement is hereby incorporated by reference. Such Collateral included designated patent applications, patents, and trademarks, as specified in the attached Schedule 1 (the “**Intellectual Property**”), including U. S. patents and applications (the “**U.S. Patents**”) and U.S. trademark registrations (the “**U.S. Trademarks**”), to secure an underlying debt or obligation as specified in associated “Promissory Notes”;

WHEREAS the Agreement reflecting the Security Interest in the Collateral to the Secured Party was recorded in the United States Patent and Trademark Office (“**USPTO**”) against the U.S. Patents on August 1, 2023, at reel 064452 and frame 0642, and against the U.S. Trademarks on August 3, 2023, at reel 8155 and frame 0533, and also recorded against other secured parties elsewhere;

WHEREAS the underlying debt or obligation has been terminated, retired, canceled, satisfied or released;

NOW THEREFORE for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Secured Party hereby releases and terminates all liens, pledges and security interests in and on the Collateral granted by Granting Party in favor of Secured Party, and relinquishes any and all right, title and interests it may have in the Collateral. This Release is binding on all heirs, successors and assigns.
