## PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT (the "Assignment") is made this 8<sup>th</sup> day of November, 2024 (the "Effective Date") between ASYMMETRIC TECHNOLOGIES, LLC, a limited liability company organized under the laws of the state of Maryland, with its principal place of business at 44191 Airport Road, Suite D, California, MD 20619, hereinafter referred to as "ASSIGNOR", and LACO HOLDINGS LLC, a company organized under the laws of the state of Ohio, with its principal place of business at 6161 Riverside DR., Dublin Ohio 43017, hereinafter referred to as "ASSIGNEE".

WHEREAS, ASSIGNOR is the sole owner of all right, title, and interest in and to all U.S. and foreign patents and patent applications listed on the attached Exhibit A and incorporated by reference into this Agreement (collectively, the "Patents");

NOW, THEREFORE, to all whom it may concern, be it known that for good and valuable consideration by ASSIGNEE to ASSIGNOR, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR does hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns, all of ASSIGNOR'S right, title and interest worldwide in, to, and under the Patents, including all provisional applications, non-provisional applications, divisions, renewals, continuations, and continuations-in-part, thereof, and all Letters Patents of the United States or any country or countries foreign to the United States hereby authorized which may be granted thereon and all reissues and extensions thereof (including, without limitation, all proceeds thereof and the rights to sue for any past, present and future infringement of said Patents and to collect all damages relating thereto), and all applications for Letters Patents which may hereafter be filed for said Patents in the United States or any country or countries foreign to the United States, and all Letters Patents which may be granted for said Patents in the United States or any country or countries foreign to the United States hereby authorized, and requests the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to record ASSIGNEE as the owner of all such Patents and issue all Letters Patents for said Patents to the said ASSIGNEE, as assignee of any patent applications listed on Exhibit A hereto, for the sole use of ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

ASSIGNOR also assigns to ASSIGNEE, all right, title and interest in and to the inventions disclosed in said Patents throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs throughout the world, including all rights to publish cautionary notices reserving ownership of said inventions and all rights to register said inventions in appropriate registries; and ASSIGNOR further agrees to execute and deliver at a future date, for no additional consideration, all powers of attorney, applications, assignments, declarations, affidavits, and any additional documents in connection therewith that the ASSIGNEE

reasonably determines are required to perfect such right, title and interest in ASSIGNEE or reflect the ASSIGNEE'S ownership of the Patents anywhere in the world.

ASSIGNOR will assist in obtaining or providing any further documents which may be required to confirm chain or title thereto.

ASSIGNOR will communicate to ASSIGNEE, its successors and assigns or their representatives, any facts known to ASSIGNOR respecting said Patents and inventions disclosed therein; and, upon request by and at the expense of ASSIGNEE, ASSIGNOR will fully cooperate in any legal proceedings or legal actions relating to the Patents brought by or against ASSIGNEE in all countries throughout the world, including any proceeding within the United States Patent and Trademark Office or other Patent Office anywhere in the world, relating thereto.

ASSIGNOR PROVIDES AND ASSIGNEE HEREBY ACCEPTS AND TAKES ASSIGNMENT AND OWNERSHIP OF THE PATENTS "AS IS" WITHOUT WARRANTY OR REPRESENTATION OF ANY KIND, INCLUDING, WITHOUT LIMITATION, ANY REPRESENTATIONS OR WARRANTIES AS TO MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, VALIDITY, ENFORCEABILITY, PATENTABILITY OF ANY OF THE PATENTS OR TO THE INFRINGEMENT OR NON-INFRINGEMENT OF THE PATENTS BY ANY THIRD PARTY OR THIRD PARTY PRODUCT(S). Effective as of the Effective Date, ASSIGNEE releases ASSIGNOR and Affiliates of ASSIGNOR from all claims and causes of action of any kind whatsoever, whether known or unknown, relating to the Patents. This release includes all successors and assigns, directors, shareholders, officers, attorneys, agents and employees of ASSIGNOR and of Affiliates of ASSIGNOR.

Nothing contained in this Assignment shall be construed as conferring any rights to ASSIGNEE, by implication, estoppel or otherwise, including, without limitation, any rights under other patents, patent applications or any other intellectual property of ASSIGNOR or any Affiliate of ASSIGNOR, except with respect to the express assignment of the Patents as set forth above.

ASSIGNOR covenants that ASSIGNOR has the full right to convey the interest assigned by this Assignment, and that ASSIGNOR has not executed and will not execute any agreement in conflict with this Assignment.


This Assignment shall be binding on the parties' successors, assigns, and legal representatives.
