

This TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS (this "Termination and Release") is made as of January 8, 2025 by BANK OF AMERICA, N.A. as administrative agent for the Secured Parties (together with its successor(s) thereto in such capacity, the "Agent"), in favor of FKA DISTRIBUTING CO., LLC, a Michigan limited liability company ("Parent"), HOMEDICS USA, LLC, a Michigan limited liability company ("HoMedics"), HOUSE OF MARLEY, LLC, a Michigan limited liability company ("Marley" and together with Parent and HoMedics, being collectively the "U.S. Borrowers" and the "U.S. Guarantors"), FKA BRANDS LIMITED (f/k/a HOMEDICS GROUP LIMITED), a company incorporated in England and Wales with company number 04353765 (the "UK Borrower" and together with the U.S. Borrowers, being collectively, the "Borrowers"), LUDGATE 329 LIMITED, a company incorporated in England and Wales with company number 04993514 ("Ludgate"), FKA HOUSEWARES LIMITED (f/k/a SALTER HOUSEWARES LIMITED), a company incorporated in England and Wales with company number 06135840 ("FKA Housewares"), FKA (HOMEDICS) LIMITED (f/k/ a GEORGE SALTER & CO. LIMITED), a company incorporated in England and Wales with company number 04395486 ("FKA Homedics"), FKA BRANDS LIMITED, a private company limited by shares incorporated in Ireland (registered no. 644333), whose registered office is at 29 Earlsfort Terrace, Dublin 2 (the "Irish Subsidiary" and, together with Ludgate, FKA Housewares, FKA Homedics and the UK Borrower, being collectively, the "UK" Guarantors" and the UK Guarantors and U.S. Guarantors, being collectively, the "Guarantors"), solely to the extent set forth therein, A.R. WHEREAS, the Grantors have requested that the Agent provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the patents and patent applications as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, without recourse, representation, or warranty of any
