I, Iveta Cabajova, declare:

1. I am over 18 years old. I have personal knowledge of the facts stated herein and could testify competently thereto if called to do so.

2. I am the CFO & COO of 1E Limited (“1E”). I have been employed by 1E since 1st December 2023.

3. 4. Notice of the IP Security Agreement was also recorded at the United States Copyright Office on April 13, 2017 at Volume 9946, Document 474.


