**ARTICLES OF AMENDMENT
TO THE RESTATED ARTICLES OF INCORPORATION
FOR**

FREUND VECTOR CORPORATION

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to Sections 490.1003 and 490.1006 of the Iowa Business Corporation Act, as amended (the "Act"), the undersigned corporation (the "Corporation") hereby adopts the following amendment to the Corporation's Restated Articles of Incorporation:

1. Name of Corporation. The name of the Corporation before this amendment of its Restated Articles of Incorporation is Freund Vector Corporation.
 - A. The caption of the Restated Articles of Incorporation, "RESTATED ARTICLES OF INCORPORATION OF FREUND VECTOR CORPORATION" is deleted and the following caption is substituted in lieu thereof: "RESTATED ARTICLES OF INCORPORATION OF FREUND, INC."
 - B. Article I of said Restated Articles of Incorporation is Amended to delete the first and only sentence in its entirety and substitute in lieu thereof;

"Article I. The name of the Corporation is Freund, Inc."
2. Shareholder Approval. The amendment was duly approved by the Shareholders in the manner required by the Act and by the Corporation's Articles of Incorporation.
3. Effective Date. The effective date of these Articles of Amendment shall be the later of June 3, 2024 or the date of the filing of these Articles of Amendment with the Secretary of State of the State of Iowa.


