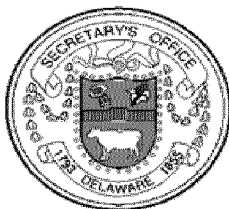

Pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Company Act (“DLLCA”), the undersigned limited liability company, Harvey Building Products Intermediate, LLC, a Delaware limited liability company (“HBP Intermediate”), does hereby certify the following information relating to the merger (the “Merger”) of Harvey Intermediate, LLC, a Delaware limited liability company, with and into HBP Intermediate:

1. The constituent limited liability companies (“Constituent LLCs”) participating in the Merger are: (i) Harvey Intermediate, LLC, a Delaware limited liability company, and (ii) Harvey Building Products Intermediate, LLC, a Delaware limited liability company.
2. An Agreement and Plan of Merger (as amended or modified from time to time, the “Merger Agreement”), dated as of December 23, 2024 has been approved and executed by each of the Constituent LLCs in accordance with Section 18-209 of the DLLCA.
3. The surviving limited liability company in the Merger is Harvey Building Products Intermediate, LLC (“Surviving Entity”), which will continue its existence as a limited liability company governed under the laws of the State of Delaware. The name of the Surviving Entity shall, effective at the effective time of the Merger, be “Harvey Building Products Intermediate, LLC”.
4. Upon the consummation of the Merger, the Certificate of Formation of HBP Intermediate as in effect immediately prior to the Merger, shall be the Certificate of Formation of the Surviving Entity until thereafter changed or amended as provided therein or by the DLLCA.
5. The Merger shall become effective at 8:07am ET on December 31, 2024.
6. An executed copy of the Merger Agreement is on file at the principal place of business of the Surviving Entity, the address of which is 5020 Weston Parkway, Suite 400, Cary, N.C. 27513.
