PATENT ASSIGNMENT AGREEMENT

This **PATENT ASSIGNMENT AGREEMENT** (“**Patent Assignment**”), dated as of October 8, 2024 is made by **HSP Technologies, LLC**, a Florida limited liability company, located at 1128 Royal Palm Beach Blvd. #166, Royal Palm Beach, FL 33411, **Pioneering Innovations, LLC**, a Florida limited liability company, located at 16363 NW 49 Ave., Miami FL 33014, and **Hair Sense Holdings LLC**, a Florida limited liability company, located at ~~6363 Nw 49 Avenue~~ 16363 NW 49 Ave. Miami, FL 33014. /NMT/ 01-29-2025

WHEREAS, HSP Technologies desires to convey, transfer, and assign to Pioneering Innovations certain intellectual property of HSP Technologies as listed herein, and whereas Pioneering Innovations, in turn, desires to convey, transfer, and assign these same rights to Hair Sense Holdings LLC, and wherein Hair Sense desires to obtain these rights;

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, HSP Technologies LLC hereby irrevocably conveys, transfers, and assigns to Pioneering Innovations LLC, and Pioneering Innovations LLC hereby accepts, all right, title, and interest in and to the following (the “Assigned Patents”). Likewise, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Pioneering Innovations LLC hereby irrevocably conveys, transfers, and assigns to Hair Sense Holdings LLC, and Hair Sense Holdings LLC hereby accepts, all right, title, and interest in and to the Assigned Patents:

- (a) the patents and patent applications set forth in Schedule 1 hereto, any other patents or patent applications based in whole or in part upon such patents or patent applications in any country (including any Patent Cooperation Treaty, national entries, issuances, divisional, renewal, substitute, continuation, continuation-in-part applications, reissues, extensions, reexaminations, and renewals thereof);
- (b) all rights of any kind whatsoever of the assigning party accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;
- (c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
- (d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Representations and Warranties. The assigning party represents and warrants that it has the full right to convey the entire interest to the Assigned Patents, and that the assigning party has not executed, and will not execute, any agreement in conflict herewith.

3. Recordation and Further Actions. The assigning party hereby authorizes the Commissioner for Patents in the United States Patent and Trademark Office, and the officials of corresponding entities or agencies in any applicable jurisdictions, to record and register this Patent Assignment upon request by the receiving party. Following the date hereof, upon the receiving party's reasonable request, the assigning party shall take such steps and actions, and provide such cooperation and assistance to the receiving party and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned Patents to the receiving party, or any assignee or successor thereto.

4. Counterparts. This Patent Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Patent Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Patent Assignment.

5. Successors and Assigns. This Patent Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

6. Governing Law. This Patent Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Patent Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Ohio, without giving effect to any choice or conflict of law provision or rule (whether of the State of Ohio or any other jurisdiction).




