## **Termination and Release of Patent Security Agreement**

This Termination and Release of Patent Security Agreement (this “Release”) is made as of January 31, 2025, by TRUIST BANK, as administrative agent (in such capacity, together with its successors and permitted assigns, the “Administrative Agent”) for the Secured Parties and for the banks and other financial institutions (the “Lenders”) from time to time parties to the Revolving Credit and Term Loan Agreement, dated as of June 5, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among CROM, LLC (“Debtor”), others Borrowers party thereto, the lenders from time to time party thereto and Administrative Agent.

### WITNESSETH:

WHEREAS, Debtor and the other grantors party thereto and Administrative Agent entered into the Guaranty and Security Agreement, dated as of June 5, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Guaranty and Security Agreement”), and the Debtor entered into the Patent Security Agreement, dated as of June 5, 2020 with Administrative Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Patent Security Agreement”) and recorded with the United States Patent and Trademark Office on June 9, 2020 in Patent Reel 006955, Frame 0206-0212.

WHEREAS, under the terms of the Guaranty and Security Agreement and the Patent Security Agreement, the Debtor mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, and granted to the Administrative Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Patent Collateral, including the patents listed on Schedule A attached hereto.

WHEREAS, the Debtor has requested, and Administrative Agent has agreed to provide, a document suitable for purposes of evidencing the release, relinquishment, discharge and termination of Administrative Agent’s Lien on and security interest in the Patent Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Administrative Agent agrees as follows:

(1) Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Guaranty and Security Agreement or the Patent Security Agreement, as applicable.

(2) Termination and Release. Administrative Agent hereby, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), releases, relinquishes and discharges its continuing security interest in the Patent Collateral, including:

(i) all Patent and all Patent Licenses providing for the grant by or to the Debtor of any right under any Patent, including, without limitation, those referred to on Schedule A hereto;

(ii) all renewals and extensions of the foregoing; and


(iii) all income, royalties, proceeds and liabilities at any time due or payable under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

(3) Further Assurances. Administrative Agent agrees to take all further actions, and provide to the Borrowers, the Debtor and their respective successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Borrowers, the Debtor and their respective successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
