FURTHER, Assignor agrees to communicate to Assignee or its representatives any facts known to Assignor respecting the Patent Rights, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuation-in-part, substitution, renewal, and reissue applications, execute all necessary assignment papers to cause any and all of the Letters Patent to be issued to Assignee, make all rightful oaths and generally do everything possible to aid Assignee, its successors and assigns, to obtain and enforce proper protection for the Patent Rights in the United States and in any and all foreign countries.
