TERMINATION TO PATENT SECURITY AGREEMENT

This **TERMINATION TO PATENT SECURITY AGREEMENT** (this “*Termination*”), dated as of February 11, 2025, is executed by NATIONAL WESTMINSTER BANK PLC (“*Security Agent*”), with an address at 250 Bishopsgate, EC2M 4AA, London, United Kingdom, in favor of PROXIBID, INC., a Delaware corporation and AUCTION MOBILITY, LLC, a Delaware limited liability company (each a “*Grantor*”, and collectively, the “*Grantors*”).

RECITALS

WHEREAS, Grantors and Security Agent entered into that certain Security Agreement, dated as of October 28, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “*Security Agreement*”);

WHEREAS, in connection with the Security Agreement, Grantors and Security Agent entered into those certain Patent Security Agreement, dated as of October 28, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “*Agreements*”) pursuant to which Grantors granted to Security Agent a security interest in the Patent Collateral (as defined in the Agreements); and

WHEREAS, Security Agent has agreed to terminate and release its security interest in the Patent Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing, Security Agent agrees as follows:

1. Security Agent hereby terminates its security interest in the Patent Collateral, including without limitation the patents listed on *Exhibit A* hereto, which security interest was evidenced by the recordation of the Agreement with the United States Patent and Trademark Office on April 5, 2022, in Reel/Frame 059598/0164.
2. Security Agent may record this Termination with the United States Patent and Trademark Office at the expense of Grantors.
3. Security Agent hereby authorizes Grantors or Grantors’ agent to record this Termination with the United States Patent and Trademark Office and any other relevant governmental authority.
4. This Termination and the rights and obligations of the parties under this Termination shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.


