TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT (this "Termination"), is dated as of February 11, 2025, and made by **PNC BANK, NATIONAL ASSOCIATION** (together with its successors and assigns, the "Agent"), to **TRICENTIS AMERICAS, INC.**, a Delaware corporation ("Tricentis Americas") and **TRICENTIS GMBH**, a company organized under the laws of Austria ("GmbH") and, together with Tricentis Americas, collectively the "Grantors" and, individually, the "Grantor").

WHEREAS, pursuant to that certain (i) Security Agreement (Patent), dated as of May 13, 2019, and (ii) Security Agreement (Patent), dated as of November 1, 2023 (collectively, the "Patent Security Agreements"), made by the Grantors in favor of the Agent, a security interest was granted by Grantors to the Agent in and to all of Grantors' right, title and interest in, to and under Grantors' owned or thereafter acquired Intellectual Property, including the federally registered patents and patent applications referred to on **Exhibit A** hereto (collectively, the "Patent Collateral");

WHEREAS, the Patent Security Agreements were recorded with the United States Patent and Trademark Office on (i) May 15, 2019, at Reel/Frame 049187/0502 and (ii) November 2, 2023, at Reel/Frame 065440/0283; and

WHEREAS, the Agent now desires to terminate the Patent Security Agreements and terminate, release and discharge its security interest in all of the right, title and interest in and to the Patent Collateral and reconvey any and all of its right, title and interest in and to the Patent Collateral to Grantors.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Agent hereby states as follows:

1. Definitions. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Patent Security Agreements.

2. Release of Security Interest. The Agent hereby (a) terminates the Patent Security Agreements, (b) terminates, releases and discharges, in its entirety, all of its security interest in and to all of Grantors' right, title and interest in, to, and under the Patent Collateral, and (c) reassigns to the Grantor or Grantors legally entitled thereto all right, title and interest of the Agent (if any), in, to and under the Patent Collateral.

3. Governing Law. This Termination and the rights and obligations of the parties hereunder shall be governed by, and construed and interpreted in accordance with, the laws of the state of New York, without regard to any principle of conflicts of law that could require application of any other law.
