RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTEREST IN PATENTS (this "Release") is made as of February 20, 2025 by Wilmington Savings Fund Society FSB, as Collateral Agent for the Secured Parties (the "Collateral Agent"), in favor of each of Lumileds LLC, a Delaware limited liability company ("Lumileds").

WHEREAS, Security Interests were established under and pursuant to a certain U.S. Collateral Agreement, dated as of June 30, 2017, as reaffirmed by a certain Reaffirmation Agreement, dated as of October 31, 2022, made by Bright Bidco B.V., a private company with limited liability incorporated under the laws of The Netherlands, in favor of Deutsche Bank AG New York Branch, as predecessor-in-interest to the Collateral Agent ("Deutsche Bank"). The Security Interests reflected on that certain Notice of Grant of Security Interest in Patents dated as of December 8, 2022, made by Lumileds in favor of Deutsche Bank, were recorded with the United States Patent and Trademark Office (the "USPTO") on July 7, 2017 and appear on Reel 043108 / Frame 0001 of the official USPTO assignment records. The Security Interests were subsequently assigned by Deutsche Bank to the Collateral Agent by a certain Assignment of and Amendment to Intellectual Property Security Agreements, dated as of April 4, 2023 (the "Assignment"). The Assignment was not registered at the official USPTO assignment records and accordingly the Security Interests are still registered in name of Deutsche Bank in the official USPTO assignment records.

WHEREAS, the management of the Borrower has determined in good faith that the Patents are not material to the operation of the business of the Borrower of any of its Subsidiaries.

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, the Collateral Agent hereby unconditionally and expressly releases, terminates, and extinguishes its security interests (the "Security Interests") in the patent applications and granted patents (collectively, the "Patents") listed on Schedule A attached hereto and made a part hereof. Lumileds agrees with the Collateral Agent that it will inform Deutsche Bank that the Security Interests in the Patents are released and request Deutsche Bank to register this Release at USPTO.



Unless otherwise defined herein, capitalized terms used herein shall have the meanings assigned to them in that certain credit agreement originally dated as of June 30, 2017 made between, among others, Lumileds and Deutsche Bank. The Collateral Agent consents and agrees to execute and deliver, at the request and cost of Lumileds, such further instruments, documents, and release forms as Lumileds may reasonably request to more effectively release, terminate and extinguish any remaining security interests upon the Patents.

This Release shall be binding upon Wilmington's legal representatives, assigns, and successors.
