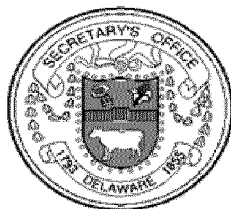

This Amended and Restated Certificate of Formation of **BASF Agricultural Solutions Seed US LLC** (the "LLC"), dated as of September 23, 2024, has been duly executed and is being filed by Brendan J. FIRST. The name of the limited liability company formed hereby is BASF Agricultural Solutions US LLC.


