and including the right to all causes of action, remedies, and other enforcement rights related to the above-identified patent or applications, including without limitation the right to sue for past, present, or future infringement, misappropriation, or violation of any and all rights related to the above-identified patent or applications and any of the foregoing, including the right to obtain and collect damages for past, present, or future infringement;


