TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Termination and Release of Intellectual Property Security Agreement (this “**Release**”) dated as of February 21, 2025, is executed by **AVENUE CAPITAL MANAGEMENT II, L.P.**, a Delaware limited partnership, as administrative and collateral agent (in such capacity, together with its successors and assigns, the “**Secured Party**”), and in favor of **RAPIDDEPLOY, INC.**, a Delaware corporation (“**Grantor**”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the IP Security Agreement (defined below).

RECITALS

A. The Intellectual Property Security Agreement, dated as of March 28, 2024, executed by Grantor in favor of Secured Party or the Lenders (as amended, amended and restated, supplemented or otherwise modified from time to time from time to time, the “**IP Security Agreement**”), was entered into in conjunction with that certain Loan and Security Agreement, dated as of March 28, 2024, as supplemented by that certain Supplement to Loan and Security Agreement dated as of March 28, 2024, by and among Secured Party, the Lenders party thereto (each a “**Lender**” and collectively the “**Lenders**”), and Grantor (as amended, amended and restated, supplemented or otherwise modified from time to time from time to time, the “**Loan and Security Agreement**”), pursuant to which Grantor granted to Secured Party a security interest in all right, title, and interest to substantially all of its personal property, including without limitation the copyrights listed on Exhibit A hereto, the trademarks and trademark applications listed on Exhibit B hereto, and the patents and patent applications listed on Exhibit C hereto (such copyrights, trademarks and trademark applications, and patents and patent applications, the “**Intellectual Property**”).

B. Pursuant to the IP Security Agreement, Grantor pledged and granted to the Secured Party or the Lenders, a security interest in all of Grantor’s right, title and interest in, to and under all of the IP Collateral (as defined below). The IP Security Agreement was recorded with the US Patent and Trademark Office (“USPTO”) on March 29, 2024 at Reel No. 8383, Frame No. 0955, for the Trademarks (as defined below) listed on Exhibit B attached hereto and at Reel No. 066944, Frame No. 0803, for the Patents (as defined below) listed on Exhibit C attached hereto.

C. Secured Party, for itself and on behalf of the Lenders, agrees to discharge fully, terminate and release its security interest in all the Intellectual Property specified below.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party, for itself and on behalf of the Lenders, hereby agrees as follows:

1. (a) The IP Security Agreement and (b) with respect to the Intellectual Property, the Loan and Security Agreement, are hereby terminated and of no further force and effect.

2. Secured Party hereby expressly irrevocably and unconditionally terminates, cancels, fully discharges and releases the security interest pledged and granted by Grantor to the Secured Party and/or the Lenders in any and all right, title and interest of Grantor in, to and under any and all of the following (the “**IP Collateral**”), including, without limitation, all of the Intellectual Property, and reassigns, transfers and conveys to Grantor any and all right, title and interest of Secured Party (if any) therein or thereto, including, in each instance, any and all of the foregoing granted to Secured Party and/or the Lenders pursuant to the IP Security Agreement and/or the Loan and Security Agreement:

(a) all copyright rights, copyright applications, copyright registrations and like protections in each work or authorship and derivative work thereof, whether published or unpublished and whether or not the same also constitutes a trade secret, now or hereafter existing, created, acquired or held all of the copyrights, whether then owned or at any time thereafter acquired, of Grantor (collectively, the “**Copyrights**”), including the copyrights listed on Exhibit A, and all registrations and pending applications associated therewith;

(b) all of the trademarks, whether then owned or at any time thereafter acquired, of Grantor that are registered with, or for which applications for registration have been filed with, the United States Patent and Trademark Office (collectively, the "**Trademarks**"), including the trademarks listed on Exhibit B, and all registrations and pending applications associated therewith;

(c) all patents, patent applications and like protections including without limitation improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same (collectively, the "**Patents**") including without limitation those listed on Exhibit C;

(d) all mask works or similar rights available for the protection of semiconductor chips or other products (collectively, the "**Mask Works**");

(e) all trade secrets, and any and all intellectual property rights in computer software and computer software products;

(f) all design rights;

(g) all claims for damages by way of past, present and future infringement of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights identified above;

(h) all licenses or other rights to use any of the Copyrights, Patents, Trademarks, or Mask Works, and all license fees and royalties arising from such use to the extent permitted by such license or rights; and

(i) all amendments, renewals and extensions of any of the Copyrights, Trademarks, Patents, or Mask Works; and proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.

3. Secured Party represents and warrants that it has the full power and authority to execute this Release for itself and on behalf of the Lenders.

4. Secured Party hereby authorizes the Grantor or its authorized representative to record or file this Release with the United States Copyright Office, the Trademark Division of the United States Patent and Trademark Office, and the Patent Division of the United States Patent and Trademark Office, at the Grantor's sole cost and expense.

5. Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the termination, release, or reassignment to the Grantor of the security interest contemplated hereby (at the Grantor's sole cost and expense).

6. This Release and the rights and obligations of the parties hereunder shall be governed by, and construed in accordance with, the law of the State of California, without regard to principles of conflicts of laws that would result in the application of the laws of any other jurisdiction.
