**PARTIAL TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

**THIS PARTIAL TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “Termination”), is dated as of March 3, 2025, and made by **WELLS FARGO BANK NATIONAL ASSOCIATION**, as Administrative Agent (the “Agent”), to **SUMNER MANUFACTURING COMPANY, LLC**, a Delaware corporation, and **SOUTHWIRE COMPANY, LLC**, a Delaware limited liability company (individually “Grantor” and collectively, “Grantors”).

WHEREAS, Grantors and Agent entered into that certain Grant of Security Interest in Trademark Rights dated February 11, 2014 (as amended, restated or supplemented from time to time, the “Trademark Security Agreement”) with respect to certain trademarks, Grant of Security Interest in Patent Rights dated February 11, 2014 (as amended, restated or supplemented from time to time, the “Patent Security Agreement”) with respect to certain patents, and Grant of Security Interest in Copyright Rights (as amended, restated or supplemented from time to time, the “Copyright Security Agreement” together with the Trademark Security Agreement and Patent Security Agreement, the “Security Agreements”);

WHEREAS, the Patent Security Agreement was recorded by the Patent Division of the United States Patent and Trademark Office on February 21, 2014 at Reel 032308 Frame 0469, February 2, 2017, at Reel 041173, Frame 0226, May 17, 2018 at Reel 046183, Frame 0644, June 19, 2019 at Reel 049522, Frame 0836, and September 16, 2021, at Reel 057552, Frame 0299;

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on February 20, 2014 at Reel 5220, Frame 0312, February 3, 2017 at Reel 5981, Frame 0959, May 17, 2018, at Reel 6387, Frame 0327, June 19, 2019 at Reel 6680, Frame 0240, and September 20, 2021, at Reel 7426, Frame 0206;

WHEREAS, amendment number three to the Copyright Security Agreement was recorded by the United States Copyright Office on August 20, 2021 at V15003 D390; and

WHEREAS, Agent now desires and terminate, release and discharge solely its security interest in the Grantors’ Intellectual Property listed on Schedule I;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Definitions. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement.

2. Release of Security Interest. Agent hereby releases, terminates, cancels, relinquishes and discharges, without representation or warranty, any security interest of any kind it may have in, and any right of set-off against:

(a) the Intellectual Property, solely with regards to those items listed on Schedule I (collectively, the “Released Collateral”);

3. Partial Termination. This Termination is applicable only and solely with respect to the Released Collateral and no other Collateral arising under the Security Agreements or other Loan Documents. Except as expressly modified hereby, this Termination shall not impair, alter, modify, amend or in any way affect any of the terms, conditions, obligations, covenants or agreements contained in the Security Agreements and other Loan Documents, which shall remain in full force and effect.

4. Delivery by Facsimile. Delivery of an executed signature page to this Termination by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a signed counterpart of this Termination.

5. The Grantors, or any successor to a Grantor (including any person or entity hereafter holding any right, title or interest in or to the Intellectual Property), is hereby authorized to record this Termination solely with respect to the Intellectual Property listed on Schedule I.

6. This Termination shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
