**RELEASE OF SECURITY INTEREST
IN PATENT COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL** (this “Release”) is made as of January 31, 2025, by U.S. Bank Trust Company, National Association (as successor to U.S. Bank National Association), in its capacity as collateral agent (in such capacity, the “Collateral Agent”), in favor of Pacific Bag, LLC, a Washington limited liability company, and TricorBraun Inc., a Missouri corporation (each individually, a “Grantor”, and, collectively, the “Grantors”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto (including by reference) in the Security Agreement (defined below).

WITNESSETH:

WHEREAS, the Grantors are a party to that certain Second Lien Security Agreement, dated as of March 3, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Grantors, the other grantors party thereto and the Collateral Agent, and (ii) that certain Second Lien Patent Security Agreement, dated as of March 3, 2021 (the “Patent Security Agreement”);

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on March 03, 2021 at Reel 056036, Frame 0360;

WHEREAS, pursuant to the Security Agreement and the Patent Security Agreement, the Grantors granted to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a Security Interest in all of each Grantor’s right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreement), including the U.S. registered and applied for Patents listed on Schedule A hereto;

WHEREAS, the Collateral Agent acknowledges full payment and performance of the Secured Obligations and accordingly has agreed to terminate the Patent Security Agreement, release its Security Interest in the Patent Collateral, and to re-convey any and all of its rights in the Patent Collateral to the Grantors.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby (i) terminates the Patent Security Agreement, (ii) releases, relinquishes, cancels and discharges all of its Security Interest (as defined in the Patent Security Agreement) in the Patent Collateral, and (iii) re-assigns, re-transfers and re-conveys to the Grantors any and all right, title or interest it may have in, to and under the Patent Collateral.

The Collateral Agent hereby authorizes the Grantors, or the Grantors’ authorized representatives, to: (a) record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the Collateral Agent’s security interest in the Patent Collateral. The Collateral Agent agrees to execute and deliver to the Grantors all other instruments and other documents as may be necessary or proper

to release the security interest in the Patent Collateral which had been granted under the Security Agreement and the Patent Security Agreement.

The Collateral Agent authorizes and requests that the Commissioner for Patents and any other applicable government officer record this Release.


This Release may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Release by signing and delivering one or more counterparts.
