## **TERMINATION AND RELEASE OF GRANTS OF SECURITY INTERESTS IN UNITED STATES PATENTS**

This Termination and Release of Grants of Security Interests in United States Patents (this "Patent Release") is dated the 18th day of December, 2024, by Medallion Capital, Inc. (the "Grantee") in favor of Roman Products, LLC, and its successors, legal representatives and assignees (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement and the Security Agreement (in each case, as hereinafter defined), as applicable.

### **RECITALS**

Pursuant to the terms of that certain Security Agreement dated as of December 11, 2019 (as may have been amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), the Grantor executed and delivered that certain Patent Security Agreement in favor of the Grantee dated December 11, 2019, which was recorded with the U.S. Patent and Trademark Office on December 18, 2019 at Reel 51300 and Frame 0521 (the "Patent Security Agreement").

Pursuant to the Security Agreement and the Patent Security Agreement, the Grantor granted to the Grantee a security interest in all of the Patents set forth on Schedule A attached hereto then owned or from time to time thereafter owned or acquired by the Grantor, including the Patent Collateral.

The Grantee has agreed to terminate and release its security interest and all of its right, title and interest in the Patent Collateral as herein provided.

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Grantee states as follows:

1. Release and Assignment. The Grantee hereby terminates the Patent Security Agreement and releases, terminates and discharges all of its right, title and interest in, to and under the Patent Collateral, and the Grantee hereby assigns and transfers to the Grantor, without recourse, all of the Grantee's right, title and interest in and to each of the Patent Collateral, effective as of the date set forth above.
2. CHOICE OF LAW. THIS PATENT RELEASE SHALL BE DEEMED TO BE EXECUTED AND HAS BEEN DELIVERED AND ACCEPTED IN MINNEAPOLIS, MINNESOTA BY SIGNING AND DELIVERING IT THERE. ANY DISPUTE BETWEEN THE PARTIES HERETO ARISING OUT OF, CONNECTED WITH, RELATED TO, OR INCIDENTAL TO THE RELATIONSHIP ESTABLISHED BETWEEN THEM IN CONNECTION WITH THIS PATENT RELEASE, AND WHETHER ARISING IN CONTRACT, TORT, EQUITY, OR OTHERWISE, SHALL BE RESOLVED IN ACCORDANCE WITH THE INTERNAL LAWS AND NOT THE CONFLICTS OF LAW PROVISIONS OF THE STATE OF MINNESOTA.
3. Severability. Wherever possible, each provision of this Patent Release shall be interpreted in such manner as to be effective and valid under applicable law, but if any provision of this Patent Release shall be prohibited by or invalid under applicable law, such provision shall be ineffective only to the extent of such prohibition or invalidity, without invalidating the remainder of such provision or the remaining provisions of this Patent Release.
4. Counterparts. This Patent Release may be executed in any number of counterparts which shall together constitute one and the same agreement.
5. Further Assurances. The Grantee agrees to execute, acknowledge, procure and deliver to Grantor any and all further documents or instruments and do any and all further acts which the


Grantor (or their respective agents, designees or assignees) reasonably requests in order to confirm, effectuate or record this Patent Release and Grantor's (or their successors' or assignees') right, title and interest in and to the Patent Collateral.

6. Recordation. The Grantor, or any successor to the Grantor (including any person or entity hereafter holding any right, title or interest in or to the Patent Collateral) is hereby authorized to record this Patent Release with the United States Patent and Trademark Office.
