## TRANSFER STATEMENT

Pursuant to § 9-619 of the Uniform Commercial Code, Water for Commerce Fund Management, LLC in its capacity as secured party (in such capacity, “**Secured Party**”) under the Financing Documents (as defined on Exhibit A hereto), hereby delivers this Transfer Statement, dated October 4, 2024, and certifies as follows:

1. Secured Party and Gel Blaster, Inc. (the “**Debtor**”) previously entered into financing arrangements pursuant to which Secured Party made secured loans and advances, and provided other financial accommodations, to Debtor as set forth in the Financing Documents.
2. Pursuant to the Financing Documents, as collateral security for all indebtedness and other obligations of Debtor to Secured Party, Debtor granted to Secured Party a continuing security interest in and lien upon, among other collateral, the Transferred Collateral (as defined on Exhibit A hereto).
3. Debtor has defaulted on its obligations to Secured Party under the Financing Documents.
4. In accordance with the Financing Documents, the Uniform Commercial Code and applicable law, Secured Party has exercised its post-default remedies with respect to the Transferred Collateral.
5. By reason of the exercise of such post-default remedies, Go play. Holdings Inc. (“**Buyer**”) has acquired the rights of Debtor in the Transferred Collateral.


