Assignor further irrevocably and unconditionally grants to Assignee, its successors and assigns, the right to claim for any Applications and the Assigned Patents the full benefits and priority rights of any international agreement between the United States and any foreign country or countries. Further, Assignor irrevocably and unconditionally authorizes the Assignee to file for and request that the USPTO and corresponding bodies in other Countries issue any and all patents resulting from any of the Applications and the Assigned Patents to the Assignee.

2. Further Assurances. The Assignor shall take such steps and actions, and provide such cooperation and assistance to the Assignee and its successors, assigns, and legal representatives, in connection with the Applications and the Assigned Patents, as may be necessary to effect, evidence, or perfect the assignment to the Assignee or any assignee or successor thereto, including, but not limited to: the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, documents in connection with claims or provisions of the International Convention for the Protection of Industrial Property or similar treaties and agreements, or other lawful papers; and the provision of information and testimony and cooperation in every way in obtaining issued patents.

3. Representations. Assignor represents and warrants that Assignor has the ability to convey all rights and interests herein assigned, and that there are no rights or interests outstanding inconsistent with the rights and interests granted herein.
