**EXHIBIT C TO ASSET PURCHASE AGREEMENT
CONFIRMATORY INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**

This Confirmatory Intellectual Property Assignment Agreement (this “**Agreement**”), dated as of April 1, 2025 (“**Effective Date**”), and is entered into by and among Eiji Katayama, in his capacity as the bankruptcy trustee of Funai Electric Co., Ltd., a company organized under the laws of Japan, having a principal place of business at 7-7-1, Nakagaito, Daito, Osaka 574-0013 Japan (the “**Assignor**”), and Brady Worldwide, Inc., a company organized under the laws of the State of Wisconsin, having a principal place of business at 6555 West Good Hope Road, Milwaukee, Wisconsin 53223, U.S.A. (the “**Assignee**”). In this Agreement, the Assignor and the Assignee are each referred to as a “**Party**” or collectively as the “**Parties**”. Capitalized terms used but not otherwise defined herein shall have the meanings assigned to such terms in the Asset Purchase Agreement (as defined below).

WHEREAS, the Assignor and certain of its Affiliates and the Assignee have entered into an Asset Purchase Agreement, dated as of March 28, 2025 (the “**Asset Purchase Agreement**”), and an Intellectual Property Assignment Agreement (the “**IPAA**”), dated as of April 1, 2025, pursuant to which the Assignor and certain of its Affiliates sold, transferred, assigned, conveyed, and delivered to the Assignee, and the Assignee purchased from the Assignor and certain of its Affiliates, the Purchased Assets, including the Intellectual Property Assets; and

WHEREAS, in connection with the transactions contemplated by the Asset Purchase Agreement and the IPAA, the Assignor and the Assignee have agreed to enter into this Agreement: (a) to effect the assignment to the Assignee of the Intellectual Property Assets, including the Trademarks and Patents set forth on Schedule A hereto; and (b) for recording in the United States Patent and Trademark Office and equivalent offices in other jurisdictions.

NOW, THEREFORE, in consideration of the foregoing and the other agreements and covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby irrevocably acknowledged, the Parties hereto agree as follows:

1. Assignment. The Assignor hereby irrevocably sells, conveys, assigns, transfers, and delivers to the Assignee, and the Assignee hereby purchases and accepts from the Assignor, free and clear of all Encumbrances, other than Permitted Encumbrances, all the Assignor’s right, title, and interest in, to, and under the following:

(a) the Intellectual Property Assets, including the:

(i) Trademarks set forth in Schedule A-1 (including all registrations and applications for registration set forth therein, and all extensions and renewals thereof, and all rights (including rights arising under applicable Law) to the words, images, designs, and other indicia of source or origin that are part of such Trademarks), together with all goodwill associated with any of the foregoing;

(ii) Patents set forth in Schedule A-2 (whether provisional or non-provisional and all divisionals, continuations, continuations-in-part, foreign counterparts, and reissues, substitutions, and registrations and applications for registration for any of the foregoing, and all reexaminations, extensions and renewals thereof, and all rights (including rights arising under applicable Law) with respect to the inventions covered by such Patents); and

(iii) any and all other Intellectual Property Assets;

(b) any and all rights of any kind whatsoever of the Assignor in, arising out of, or associated with any and all of the foregoing in any jurisdiction (including state, national, and supranational) throughout the world (whether statutory, common law, or otherwise, including as provided by applicable Law or by international treaties and convention), including the right to: (i) apply for, prosecute, register, and maintain any of the Intellectual Property Assets, including the foregoing set forth in Section 1(a) of this Agreement, and claim priority under applicable Law or international convention; and (ii) grant licenses or other rights or interests in or to any and all of the foregoing;

(c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action with respect to any and all of the foregoing, whether accruing before, on, or after the Effective Date, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but not the obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Further Assurances; Power of Attorney.

(a) The Assignor shall, at Assignee's own cost and expense, use its commercially reasonable efforts to promptly execute and deliver, or cause to be executed and delivered (including by applicable Affiliates), all such documents and other instruments (including affidavits, declarations, oaths, assignments, and powers of attorney), and promptly take such other actions, as the Assignee may reasonably request in order to: (i) sell, transfer, convey, assign, and deliver to the Assignee the Intellectual Property Assets; (ii) effectuate the transfer of ownership and control of the Intellectual Property Assets to the Assignee, and cause such Intellectual Property Assets to be registered or enable the Assignee to register such Intellectual Property Assets in the name of the Assignee or its designee; (iii) enable the Assignee to exercise and enjoy the intended rights and benefits of this Agreement; and (iv) record, in any applicable jurisdiction, the assignment of the Intellectual Property Assets to the Assignee.

(b) If the Assignor does not promptly comply with its obligations under this Agreement, the Assignor hereby irrevocably grants to the Assignee power of attorney, and designates and appoints the Assignee as the Assignor's agent and attorney-in-fact, in each case, to execute all documents and other instruments and take all actions, on the Assignor's behalf and in its name, to: (i) sell, assign, transfer, convey, and deliver the Intellectual Property Assets to the Assignee; (ii) further the perfection, prosecution, issuance, maintenance, protection, and enforcement of all Intellectual Property Assets to the fullest extent permitted by Law; and (iii) enable the Assignee to exercise and enjoy the intended rights and benefits of this Agreement to the fullest extent permitted by Law. The Assignor acknowledges and agrees that this power of attorney is coupled with an interest and shall not be affected by the Assignor's subsequent incapacity.

(c) The Assignee acknowledges that on the Closing Date an Assignor's parent Affiliate or another Affiliate (past or present) may be listed as the owner of record in the records of the United States Patent and Trademark Office, or the equivalent offices in any applicable jurisdiction, for some of the Trademarks or Patents included in the Intellectual Property Assets. Assignor shall use its commercially reasonable efforts to provide Assignee with the necessary documents for the correction of such records as soon as possible.

4. Recordal. Each Party hereby authorizes and requests the Commissioner of Patents and the Commissioner of Trademarks of the United States Patent and Trademark Office, and the officials of corresponding or equivalent Governmental Authorities or registrar in any applicable jurisdictions, to record and register this Agreement so as to perfect the Assignee's ownership of the Intellectual Property Assets.

5. General Provisions. Section 10.01 (Expenses), Section 10.02 (Notices), Section 10.04 (Headings), Section 10.05 (Severability), Section 10.07 (Successors and Assigns), Section 10.08 (No Third-Party Beneficiaries), Section 10.09 (Amendment and Modification; Waiver), Section 10.10(a) and Section 10.10(b) (Governing Law; Submission to Jurisdiction; Waiver of Jury Trial), Section 10.11 (Specific Performance), and Section 10.12 (Counterparts) of the Asset Purchase Agreement shall apply to this Agreement, *mutatis mutandis*, as if it had been fully set forth herein.

6. Miscellaneous. The Parties hereto acknowledge and agree that this Agreement is entered into pursuant to the Asset Purchase Agreement. The representations, warranties, covenants, agreements, and indemnities contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern. Whenever the words "include," "includes," or "including" are used in this Agreement, they will be deemed to be followed by the words "without limitation." This Agreement will survive the termination or expiration of the Asset Purchase Agreement.

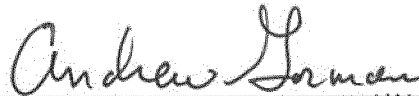

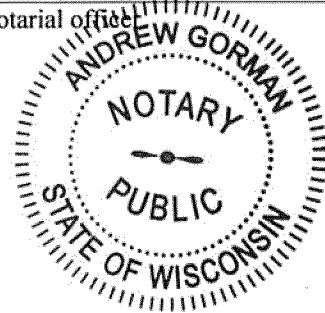
