Assignor further assigns to Assignee and Assignee further accepts (a) any improvements in the inventions previously or after the date of this Assignment made or acquired by Assignor, and any patents on the inventions and/or improvements that may be granted in the United States or any foreign countries, including each patent granted on any application that is a division, substitution, or continuation in whole or in part of an application (collectively, "Future Patents"); (b) all issuances, divisions, continuations, continuations-in-part, reissues, substitutions, extensions, reexaminations, and renewals of any of the Patents or Future Patents, whether already granted or to be granted; (c) any and all other rights and privileges accruing under the Patents or Future Patents provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world; and (d) all claims for damages arising out of or relating to past or continuing infringements of the Patents or Future Patents, if any, with the right to sue for and collect such damages.

Assignor hereby covenants that it has full right, power and authority and has been duly authorized to convey the right, title and interest herein assigned, and that it has not and will not execute any agreement in conflict herewith. Assignor further covenants that, when requested, it will without charge to Assignee, execute and deliver to Assignee any further documents and instruments, and take all such further actions as may be necessary, desirable or convenient to enable Assignee to obtain, maintain and enforce its rights and interests in and to the Patents and Future Patents in any and all countries. If Assignee or its successor or assignee is unable, for any reason, to obtain a signature of Assignor on a document necessary to perfect the transfer or assignment of the Patents, Future Patents or the intellectual property rights therein, Assignor hereby irrevocably appoints Assignee (and its successors and assigns) as Assignor's agent and attorney-in-fact, which appointment is coupled with an interest, to act for and on behalf of Assignor to execute, verify, and file any documents with the same legal force and effect as if executed by Assignor.

Assignor hereby authorizes the Commissioner for Patents in the United States Patent and

Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Patent Assignment. This Patent Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. This Patent Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

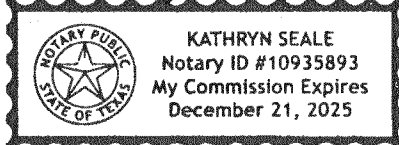

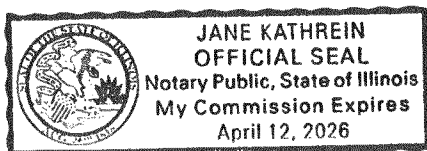
