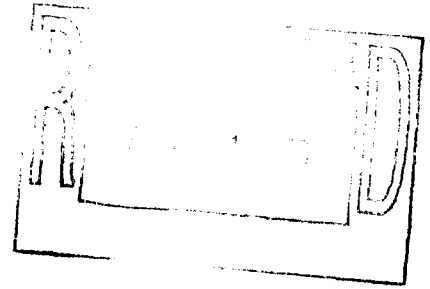

AGREEMENT OF ASSIGNMENT

This is an Agreement by and between Tomco Conversions, Inc., a Pennsylvania Corporation, having a place of business at P.O. Box 30, Midmont Road, Wilcox, PA 15870 (hereinafter "Tomco") and Walden-Hays, Inc., a New York corporation (hereinafter "W-H").

WHEREAS, W-H wishes to acquire from Tomco, and Tomco wishes to transfer to W-H, all rights which Tomco has to the trademark "THE INDEPENDENCE", the goodwill associated therewith and all other rights, if any, that Tomco has with respect to the use of the phrase THE INDEPENDENCE as a mark or a component thereof, for any and all purposes.

NOW, THEREFORE, with the intent to be legally bound, the parties agree as follows:

1. Tomco represents:

a) That the facts set forth in the foregoing recitals are true and correct;

b) That Tomco has advertised the sale of motorized wheelchairs under the mark THE INDEPENDENCE and has acquired and is the owner of goodwill as a result thereof;

c) That Tomco has forwarded a filing fee and a complete and fully executed application for federal registration to the United States Patent and Trademark Office for the trademark THE INDEPENDENCE for motorized wheelchairs and component parts thereof in International Class 12 based upon a bona fide intent to use said mark; and

d) That Tomco is not aware of any other entity or party which has any rights to adopt and utilize the mark THE

INDEPENDENCE for motorized wheelchairs and component parts thereof.

2. Other than the representations set forth in Paragraph 1 above, Tomco make no representations nor warranties to W-H regarding Tomco ownership of the mark but rather merely agrees to assign any and all rights Tomco may have in the mark THE INDEPENDENCE and the goodwill associated therewith.

3. Tomco agrees to indemnify and hold W-H and its licensees and assignees harmless of and from any damages caused as a result of a breach of this Agreement by Tomco.

4. Tomco hereby assigns to W-H all rights in and to THE INDEPENDENCE Mark, by execution of the Assignment annexed hereto as Exhibit A.

5. Tomco agrees to cease all use, and will not authorize use by any other person or entity of THE INDEPENDENCE Mark, or any mark comprised in whole or in part of the term INDEPENDENCE for any motorized wheelchair or related product or component thereof after three (3) months from the date of this agreement.

6. Tomco acknowledges receipt of the sum of \$70,000.00 as full and complete consideration for this Agreement and Assignment.

7. The parties agree that the terms of this Agreement shall remain confidential and that this Agreement shall not be recorded nor made public by either party.

8. This Agreement of Assignment constitutes the entire agreement and understanding between the parties and can not be

amended without a writing signed by authorized officials of both parties.

9. This Agreement is binding upon all successors, assigns, licensee, subsidiaries and divisions of both parties. The rights and obligations of this Agreement shall be freely assignable. By taking an assignment, an assignee shall be deemed to have accepted and agreed to perform all of the rights and obligations of the assignor under this Agreement.

10. This Agreement shall be construed in accordance with the laws of the Commonwealth of Pennsylvania.

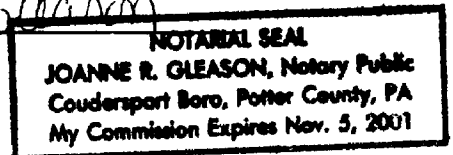


